

COOKIES POLICY

I. GENERAL PROVISIONS

1. The web site at the domain: http://dcelltherapies.com/ is administered by 4CELLTHERAPIES S.A. with the registered office in Gliwice at the address: ul. Bojkowska 59C, 44-100 Gliwice, entered under identification number KRS: 0000692806 into the register of entrepreneurs in the National Court Register, maintained by the 10th Economic Department of the National Court Register at the District Court in Gliwice; with the initial capital of 1,880,468.50 PLN, fully paid, identified by tax-identification number [NIP]: 5252547574, and Company ID [REGON]: 146535883 hereinafter referred to as the "Administrator".

II. COOKIE FILES

- 1. The Administrator's web page uses cookies.
- 2. It is necessary to install cookies for correct provision of services at the web site. Cookie files contain information indispensable for correct functioning of the web page and they also make it possible to prepare general statistics of visits to the web site.
- 3. Two types of cookie files are used at the web site, namely session cookies and persistent cookies:
 - session cookies are temporary files that are stored on the user's terminal device until he logs out (leaves the web site);
 - b. persistent cookies are stored on the user's terminal device for the time period specified in the parameters of cookie files or until they are removed by the user.
- 4. The Administrator uses his own cookie files in order to learn more about, how the user interacts with the web page content. The files collect information about the manner, in which the user interacts with the web site, about the type of the web site, from which the user has been redirected and about the number and duration of user's visits to the web site. The information does not contain any specific personal data of the user, but is used to prepare statistics of web page usage.
- 5. The user has the right to decide about the extent, to which cookie files get access to his/her computer, and to do so through their selection in the web browser window. Specific information about the possibility and methods of supporting cookie files are available in software settings (of the web browser).
- 6. Cookie files do not change the configuration of the devices used by the user; they are not used to install or uninstall any computer programs, neither do they interfere with the integrity of the user's system or data.

III. FINAL PROVISIONS

We encourage the user who passes to other web sites or services to get acquainted with their respective rules concerning privacy policy (personal data processing) and handling of cookie files.
